HIDRAMAR S.L., afloat ship repair center; TENERIFE SHIPYARDS S.A., shipyard for the repair, conversion and adaptation of general ships and offshore units, provides services and technical assistance in the Naval, Industrial and Oil&Gas sectors. Project management, design, construction, installation, manufacture, repair and maintenance of naval and industrial machinery, structures and installations, including metallic constructions and hydraulic circuits. Sale and distribution of goods and equipment for installations and repairs of machinery, naval and industrial structures; and HIDRAMAR CONSTRUCCIÓN Y MANTENIMIENTO S.L., a company belonging to the construction of residential buildings, maintenance of mechanical installations and industrial and naval metallic structures.

In this Integral Management System, the fundamental pillar is continuous improvement, with the constant idea of ensuring that the work and services developed comply with legal requirements and those agreed with customers.
